Instruction Sheet for Articles of Incorporation for Domestic General Cooperative Association Form DGCA-1, Ver. 5, September 2023

Use this instruction to draft articles of incorporation for your association; or use the Articles of Incorporation on page 2. This will establish your new Domestic General Cooperative Association in the District of Columbia.

ENTITY TYPE / AUTHORITY	FILING FEE
Domestic General Cooperative Association: § 29–906. & 29-102.01	Refer to Corporate Fee Schedule posted online.

The following information is required for articles of incorporation.

- 1. The name of the association. The name of a general cooperative shall contain the words "cooperative association". "Cooperative" may be abbreviated as "Co-op" or "Coop". "Association" may be abbreviated as "Assoc.", "Assoc", "Assn.", or "Assn".
- 2. A statement as to the purpose or purposes for which the association is formed.
- 3. The term of existence of the association, which may be perpetual.
- 4. The location and address of the principal office of the association.
- 5. Registered Agent's name and address in the District Columbia.
- 6. The names and addresses of the directors who will manage the affairs of the association for the first year, unless sooner changed by the members.
- 7. A statement of whether the association is organized with or without shares and the number of shares or memberships subscribed for.
- 8. If organized with shares, a statement of the amount of authorized capital, the number and types of shares and the par value thereof
- (which may be placed at any figure), and the rights, preferences, and restrictions of each type of share.
- 9. The minimum number or value of shares which must be owned to qualify for membership.
- 10. If organized without shares, a statement of whether the property rights of members must be equal or unequal, and if unequal, the rule by which their rights shall be determined.
- 11. The maximum amount or percentage of capital which may be owned or controlled by any member, including a statement of whether or not each member is limited to a single share, and whether such single shares are of various par values.
- 12. The method by which any surplus, upon dissolution of the association, is distributed, in conformity with the requirements of § 29-934 for division of the surplus.
- State the names, residence and business addresses of each person (member and officer) whose aggregate share of direct or indirect, legal or beneficial ownership of a governance or total distributional interest of the entity:

 (A) Exceeds 10 percent; or
 - (B) Does not exceed 10 percent; provided, that the person:
 - (i) Controls the financial or operational decisions of such entity: or
 - (ii) Has the ability to direct the day-to-day operations of such entity."
- 14/15. Incorporators names and address; each Incorporator must sign and date the articles; any 5 or more natural persons or 2 or more associations can act as incorporators.
